The Village of Cross Plains is in full support of the 2023 TAP application for the Wisconsin River Recreational Bridge project. This new recreational bridge is desired to connect The Great Sauk State Trail in Sauk City with the proposed Walking Iron Trail in northwest Dane County near Mazomanie, Wisconsin. This connection will advance the "Gateway to The Driftless" regional trail system. The bridge will be designed to accommodate a variety of users including pedestrians, bicyclists, and snowmobile traffic. Due to the location and variety of user of the bridge, we anticipate a substantial positive impact on not only the Village of Sauk City, but the entire region.

This project is well supported by the public as evidenced by inclusion in both the Dane County Parks and Open Space Plan (2018-2023) and the Sauk County Comprehensive Outdoor Recreation Plan (2020-2024). The benefit and feasibility of the project is backed by a Case Study for the "Potential Economic Effects of the Gateway to the Driftless Trail System" (January 2021) and a Great Sauk State/Walking Iron Trail – Bridge Feasibility Study (December 2019).

The Village's effort to develop, protect and advance the trail system for multi-modal transportation and outdoor recreation is a step into a future that will enhance the region's economy, health, and well-being.
