- I. Call to Order Meeting called to order at 7:00 pm by Cameron Bjorklund
- II. Roll Call Present: Cameron Bjorklund, Tami Roll, Candace Montag, Randy Swingen and Kevin Engeliën. Also present: EMS Chief Tabitha Smith, Fire Chief Justin Radtke, Police Chief Tony Ruesga, Sgt. Matt Hudson, Officer Nicole Kimball, Officer Hannah Masters, Jordan Zimmerman, Daniel Nonn, Kris Limp, Mandy Kroninger, Holly Ellickson, and Brian Pitt.

- VI. Approval of Minutes from June 20, 2023, PSC Meeting:

VIII. Report of First Responders

1. Cross Plains Area EMS Chief - Chief Smith provided an update on her department and informed the committee that they are down one position but have three internal candidates being considered. EMS has responded to 303 calls for service this year and have not missed a call since Chief Smith was appointed.
2. Cross Plains Fire Chief – Chief Radtke provided an update for his department and informed the committee that they currently have 35 fire fighters but have 44 lockers. They continue to recruit but are not having any issues with getting enough staff to respond to calls. Fire has responded to 112 calls for service this year with 57 calls within the Village of CP. Chief Radtke spoke about the department’s training and assist calls for service in other jurisdictions. Fire Pancake Breakfast is scheduled for October 1st at 7:30 am.
3. Cross Plains Police Chief

Chief Ruesga provided an update for his department and informed the committee that they currently are doing backgrounds on two candidates for the open police officer position. Police has responded to 2066 calls for service Chief Ruesga reported on the lack of available squads even though the Village Board has approved the purchase of two squads. Chief Ruesga spoke about school bus safety and the letter he received from the MCPASD Transportation Center and shared on the Police Department Facebook page.

IX. Committee Discussion

1. Update Regarding Municipal Court Fine Schedule.

This item has been discussed at several meetings and will be removed from the agenda.

2. Discussion and Possible Action Regarding EMS merging onto Hwy 14 from Caesar Street.

No action taken but consensus from the committee that they would support EMS using their siren and lights to get onto Main Street and then shutting it off if not needed.

3. Update regarding Repainting the pedestrian lines on Park Street which was recommended by the PSC and approved by the Village Board at their meeting on October 24, 2022.

This has been completed.

4. Update Regarding Permanent "No Parking - during school hours Signs" on Military Road with additional yellow curb paint next to the divider which was recommended by the PSC and approved by the Village Board at their meeting on November 28, 2022.

This has been completed.

5. Update Regarding Red flag program which was recommended by the PSC and approved by the Village Board at their meeting on December 19, 2022.

This has been completed.

6. Update Regarding Stop signs on N. Hill Point Road which were recommended by the PSC and approved by the Village Board at their meeting on May 16, 2023.

This has been completed.
