

RESOLUTION NO. 2021-17

A RESOLUTION TO ADOPT WARD PLAN AND TO COMBINE MUNICIPAL WARDS FOR VOTING PURPOSES FOR THE VILLAGE OF CROSS PLAINS, DANE COUNTY, WISCONSIN

WHEREAS, Section 5.15, Wis. Stats., requires all cities, villages and towns with a population of 1,000 or more to establish municipal wards based on the results of the 2020 census;

WHEREAS, Section 59.03 (3) (b), Wis. Stats., requires that each county board adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan, dividing the county into districts and designating the approximate location and population of each ward proposed to effectuate the division of the county into districts;

WHEREAS, these laws require that each municipality designate by consecutive whole number, geographical description and population, the various wards to be created within the municipality;

NOW, THEREFORE, the Village Board of the Village of Cross Plains, Dane County, Wisconsin, hereby resolves as follows:

Section 1. Rescind Resolution No. 06-2011R.

Resolution No. 06-2011R, which establishes a Ward Plan for the Village of Cross Plains based on the results of the 2010 census, is hereby rescinded.

Section 2. Wards Established.

The following 6 Wards are created and adopted:

- a. Election Ward No. 1, Comprised of census blocks: 1020, 1023, 1026, 1027, 1035, 1039, 1040, 1058, 1079, 1080 and a total population of 825;
- b. Election Ward No. 2, Comprised of census blocks: 1008-1010, 1021, 1028-1031, 1033, 1036, 1041-1043, 1046, 1047, 1056, 1057, 1059, 1060, 1071-1074 and a total population of 810;
- c. Election Ward No. 3, Comprised of census blocks: 1044, 1045, 1050-1052, 1061, 1066-1070, 1075-1077 and a total population of 547;
- d. Election Ward No. 4, Comprised of census blocks: 1048, 1049, 1078, 2018-2020, 2031, 2032, 2034, 2035, 2038-2040 and a total population of 655;
- e. Election Ward No. 5, Comprised of census blocks: 2002, 2003, 2008-2012, 2021, 2022, 2024-2029 and a total population of 666;
- f. Election Ward No. 6, Comprised of census blocks: 1000, 1001, 1053, 1054, 2000, 2001, 2004-2007, 2013-2017 and a total population of 601;

Section 3. Common Polling Place.

Ward 1, 2, 3, 4, 5 and 6 created above are hereby combined for voting purposes so as to share a common polling place which is the Rosemary Garfoot Public Library, 2107 Julius Street. Such combined wards shall use common ballot boxes and ballots or voting machines, and separate returns shall not be maintained for the combined wards at any election, except where separate ballots are required under Sections 5.58 and 5.64, Wis. Stats. separate ballots or voting machines will be maintained for any electors of one or more of the combined wards who are ineligible to vote for any office or referendum for which other electors in the combined wards may vote.

Section 4. Clerk Duties.


Upon passage, a copy of this resolution shall be filed with the Village Clerk, who shall transmit a copy of the ward plan and this resolution to the County Clerk within five days of its adoption.

Section 5. Effective Date.

This Resolution shall take effect upon adoption and posting as provided as by law, and shall remain in effect for each election until modified or rescinded, in accordance with Statute, or until a new division is made following the next federal decennial census.
